

### LOCATION

Situated near the middle of Vancouver Island, Mount Washington is located approximately 210 Kilometers north of the capital city of Victoria, 100 kilometers north of Nanaimo; 50 kilometers south of Campbell River and 30 kilometers east of Comox Valley.



**Strathcona Parkway** is a paved Provincial highway, all-season road that links Mount Washington to the Island Highway and the Comox Valley.



Nanaimo has **two major ferry terminals** connecting Vancouver Island to the mainland via a one hour and forty-minute ferry ride.



**Direct daily flights** to Comox Valley Airport are available from Vancouver, Calgary and Edmonton with Westjet, Air Canada and Pacific Coastal. Direct flights to Victoria are offered through Alaska Air, Delta, and United from Seattle and San Francisco.
